BOAT RENTAL AGREEMENT

This Boat Rental Agreement ("Agreement") is entered into on [Date], between the undersigned Renter ("Renter") and BlueWave Boat Rentals, LLC ("Rental Provider"). The Renter and Rental Provider are collectively referred to as the "Parties."

Any violation of Texas State boating laws may result in immediate termination of the rental without a refund.

BOAT RENTAL POLICY

- **1. Eligibility and Requirements:** a. Renters must be at least 18 years old and possess a valid government-issued photo ID. b. Renters born on or after September 1, 1993, must complete a Texas Parks and Wildlife Department (TPWD) approved boater education course.
- **2. Reservation and Rental Agreement:** a. Reservations can be made in advance online or in person. b. A signed rental agreement is required before the commencement of the rental. c. The rental agreement includes the acknowledgment of understanding and compliance with all Texas State laws and regulations.
- **3. Safety Guidelines:** a. Renters must comply with all TPWD regulations and guidelines for safe boating. b. Personal flotation devices (PFDs) must be worn by all passengers as per TPWD requirements. c. All boats are equipped with required safety equipment, and renters must familiarize themselves with its location and usage.
- **4. Security Deposit and Rental Fees:** a. A security deposit is required at the time of rental, refundable upon the safe return of the boat and equipment. b. Rental fees must be paid in full before the rental period begins.
- **5. Rental Period:** a. The standard rental period is either 4 or 8 hours, and additional hours may be arranged based on availability. b. Late returns may result in additional charges.
